Hundreds say NO to 2 Child Cap and Rape Clause



The 21st of September saw over 200 people take over Bedford St in Belfast and the Guild Hall in Derry/ Londonderry to say NO to this evil policy. The rally was organised by Reclaim the Agenda and Women's Aid with support from partner organisations including WRDA.

Speeches at the rally were provided by Louise Kennedy from Women's Aid, Maria Morgan from the NI Committee of the Irish Congress of Trade Unions and Jo Smit, advice worker at Windsor Women's Centre. Alison Thewlis went through the Rape Clause form women will be expected to fill in and explained that shockingly mothers will have to name the child they conceived as a result of rape. She argued that 'social security is a right' and left the assembled crowd in no doubt that this policy is an attack on the rights of women and children.

Part of the policy could require social workers, jobs and benefits workers and other professionals to assess the cases of women who have conceived children as a result of rape. This has a unique impact in Northern Ireland due to Section 5 of the Criminal Law Act which requires anyone with information about a serious crime to report it to the police.

The cap came into force for new applicants in receipt of child tax credit in April this year and will affect many more families as they move over on to Universal Credit in the coming months. One impact of this policy is that it is preventing women from leaving abusive relationships as they would have to enter a new claim for Child Tax Credits/ Universal Credit if they were to end the relationship. It will also have an adverse effect on child poverty which is already at devastatingly high levels with 24% of Northern Irish children living in poverty. These children need Child Tax Credits/ Universal Credit and those in large families need that money even more so. It is nonsensical and actually cruel to implement this policy in an area with child poverty as chronic as NI.

There was also a striking presence at the rally from three activists dressed as 'handmaids' who are characters in the novel and recent TV series 'A Handmaid's Tale' which deals with the state controlling women's fertility. The three silent figures were a strong reminder of how much this policy intrudes on women's rights. We will continue to fight this policy until it is withdrawn.

March of The Mummies - Campaign to end Maternity Discrimination



Maternity discrimination is rife in NI. In 2016 the Equality Commission found that 50% of women surveyed felt that pregnancy and maternity leave had damaged their career prospects and 44% of mothers working part time do so because they can't find work that fits around their caring responsibilities. The campaign group Pregnant then Screwed has joined with Belfast Feminist Network, The Women's Resource and Development Agency and Reclaim the Agenda to call for an end to this discrimination.

Join us in demanding positive change such as better access to flexible working and subsidised childcare from six months at our 'March of the Mummies' rally. The event will assemble at Belfast City Hall at 12 midday on Tuesday 31st of October and will be a family friendly event with costumes welcome!









Learning Report from Reclaim the Bonfires Project

WRDA's innovative Good Relations programme on Bonfires has come to an end with the successful launch of the learning report on the 19th of September at Small Wonders in Belfast. This project looked at the position bonfires occupy locally and explored the use of bonfires internationally. It created a space to discuss the use of bonfires today and looked at how they could be used as inclusive events. Workshops covered the international history of bonfires, local experiences, sharing stories and generating ideas for the future.

The project worked with groups from a Protestant/Unionist/ Loyalist perspective and from a Catholic/Republican/Nationalist perspective as well as a cross community group. At the end of the process the groups came together and co-created recommendations for the future of bonfires.



Bonfires & Sites

- ⇒ Bonfires should be built on designated safe sites in areas with a low risk of damage to property
- ⇒ Height restrictions to prevent bonfires toppling over and a list of acceptable bonfire material such as wood
- ⇒ Community Stewards should be appointed to deal with antisocial behaviour
- ⇒ List of banned behaviour including dumping rubbish and burning tyres, election posters and effigies.
- ⇒ Provision of community storage space for the bonfire materials

Communities Managing Bonfires

- ⇒ Anonymous community consultations
- ⇒ Bonfire committees made up of local residents should be set up in each area to liaise with the PSNI, Housing Executive etc.
- ⇒ Committees should be gender balanced (50% women quota) and should include young people
- ⇒ Events should be advertised locally so people are aware of what is happening near them and at what times
- ⇒ Education workshops and a programme on the culture and history of bonfires.

Tackling illegal behaviour

- ⇒ PSNI enforcement and consequences for breaking the law
- ⇒ Education programmes on the consequences of criminal behaviour such as travel restrictions and employability problems

Media Coverage

- ⇒ Current media coverage creates competition between rival bonfires and presents a negative image of the communities in which they are built
- ⇒ Anecdotal evidence that media outlets are not interested in covering positive stories around bonfires and commemorations
- ⇒ Communities should make their own media content by contacting local providers such as NVTV

Creative Ideas

- ⇒ Themed bonfires
- ⇒ Traditional and modern youth led bonfires
- \Rightarrow Competitions to design a sculpture as the bonfire to get children involved
