

WRDA Stormont and Westminster Update – August 2021

Summary

It should be noted that Westminster and Stormont are in the middle of their summer recess and therefore there is much less to report on than usual. However, despite this there has been a number of political developments surrounding the thematic issues highlighted within the Women's Policy Group (WPG) Covid-19 Feminist Recovery Plan. This summary reflects Bills within both the Stormont and Westminster Executives, and policy consultations of the WPG & WRDA.

The issue of **violence against women and girls** featured prominently in legislation in both Stormont and Westminster. Naomi Long's Protection from Stalking Bill remains at Committee stage alongside the introduction of a Sexual Offences and Trafficking Victims Bill. In Westminster there has been no movement on the Private Member's Bills in relation to Intimate Images (Offences) Bill and Unsolicited Explicit Images and Deepfake Pornography Bill – however, they remain ones to watch. This comes in light of international news this month that the Taliban have retaken 'governance' of Kabul and Afghanistan which has resulted in the stripping of many of the human rights advances made for women in the region. As feminist organisations we must do what we can in solidarity with the women there and amplify Afghan women's voices as much as possible.

The issue of **women's economic justice** remained prominent at Stormont and Westminster with legislation in relation to childcare, maternity protections, and increasing rights of parents to take absence in tragic circumstances such as miscarriages and bereavement. Further, the WPG & WRDA responses emphasise the importance of bringing a gendered lens to such economic policies and strategies to ensure that women benefit equally.
