Without the requirement for regular monitoring, any issues or concerns run the risk of developing into more serious problems. In addition, a culture of monitoring should be well established and considered to be working well before we consider moving to less regular reporting.

The 5 years referred to here is a choice made by DAERA to reduce monitoring requirements - the very same section of the consultation document quotes the CCC saying "The CCC have said that reporting every 5 years on mitigation should be a minimum. However, they also advised that every 5 years would likely be too infrequent to drive the rapid progress needed to see any difference in cutting emissions, and it would not be enough to build a robust database (for mitigation). It was also their perspective that reporting every year (annual reporting) on mitigation by public bodies would not be necessary."

For all these reasons we are recommending reporting every two years.

We need more than the bare minimum to drive rapid change and we deserve honesty about this in our consultation documents.

We are relatively indifferent to this question, but a financial year is as good a measure as any other - it is still one year.

As stated above, we are concerned that there is a bias in this consultation to encourage those who are not careful about checking the full consultation report before replying to opt for more widely spaced reporting requirements, opting for something that prioritises the burdensomeness of reporting above the urgency of action on these matters.

We have chosen the options that we have chosen (reporting every 2 years, mitigation reporting every two years) because we grasp the absolute urgency of these actions. We also understand the importance of embedding a culture within these public bodies as soon as practically possible; rather than allowing this to become a set of requirements that is seen as an obstacle or a burden, it should be seen as a means of self-regulation and as encouragement to these bodies to take their role and responsibility seriously.
